### IMPORTANT LUNCHEON RESERVATION PROCEDURES

In response to requests from the Wyndham Hotel and a decision by the Branch Board, the luncheon reservation procedures have been fine-tuned just in time for the beginning of a new decade! The cost of the luncheon will remain \$20 for a timely reservation with payment made the day of the meeting; a check is preferred or you need to bring the correct change.

Dorothea will send a reminder e-mail one week before the meeting; you can simply reply to her email to make your reservation or you may call her at 343-0370. Reservations or cancellations MUST be received by 6 p.m. on the Wednesday before the Saturday meeting because Dorothea e-mails the Wyndham at that time—a compromise with the hotel as they wanted to receive the reservations one week in advance.

Because the Branch must pay for all reservations made, a member who does not keep her reservation will be billed for the full cost of the luncheon. If a member arrives without a reservation and expects to stay for lunch, the cost of the meal is \$30. In this situation, please check in with Dorothea (reservations) and Evelyn (treasurer) at the registration table to determine availability and to make payment; do NOT approach hotel staff directly (this is a business transaction to be handled by the treasurer).



By the 6 p.m. Wednesday deadline, Dorothea also needs to know if you are attending the program but not staying for lunch or if your luncheon reservation has any special dietary requirements such as a vegetarian meal. Seating for members attending only the meeting/program will be in chairs set up separate from those at the tables for luncheon attendees. Thus, it is important to let

Dorothea know that you will be attending the meeting/program but not staying for lunch so that the hotel will know how many additional chairs to set up.

Making our reservations on time seems like a New Year's resolution we can all keep!



November 2009 Case Update: Oral arguments for the LAF-supported case Mansourian et al. v Regents of the University of California, et al. were heard by the U.S. Court of Appeals for the 9th Circuit in October. Kristen Galles, the plaintiffs' lawyer, said the following about the oral argument, "It went great! Based on the questions and comments by the judges, I feel very optimistic that we will get a strong decision out of it. It was helpful for us to have so many civil rights groups submit amicus briefs on our behalf. It raised the profile for the court. Thanks again to AAUW for signing on to the amicus brief written by

the National Women's Law Center. We hope to have a written decision within six months." If there is a positive outcome, the case will be remanded for trial in the district court. This case illustrates how signing amicus briefs allows AAUW to influence the outcomes of strategic cases.

What great fun we had in 1991 when Dorothy Sullivan's husband drove a group of us to Brenham to visit the Antique Rose Emporium and the antique carousel in the city park. It was enchanting to listen to the calliope and watch the horses go round and round and up and down. Who knew art encompassed such a broad spectrum! Over the years that I have participated in the Art Tour Study Group, I have had many interesting experiences and had my horizons expanded.

Because the Austin area is blessed with many local artists, local galleries, and some fine museums, the opportunities to experience and enjoy art are mind-

boggling. At the University of Texas we have enjoyed exhibits at the Blanton Museum of Art (formerly the Huntington Art Gallery), the Tarleton Law Library, and the Ransom Center. At the Huntington we were given the opportunity to visit the Conservation Department, and the behind-the-scenes look at the care and expertise necessary to validate, evaluate, and preserve works of art was most informative. In addition to local museums such as the Austin Museum of Art, the Umlauf Sculpture Garden, the Elisabet Ney Museum, the Mexic-Arte Museum, the Carver Museum, and the City Hall, we have traveled to art galleries in Wimberley, the Hummel Museum in New Braunfels, and the Benini Foundation in Johnson City.

Daryl Howard, David Demmings, Damion Pryor, Michael Atkinson, Maxine Price, Linda Dumont, and Eileen Pestorius are some of the local artists whose studio we have visited. Several of the artists have given us demonstrations of how they work which always amazes a non-artist like me! Other interesting tours have included finding the outdoor murals in Austin, visiting glass-blowing studios, watching pottery creation, trekking through the Texas State Cemetery, having a pre-opening tour of the Long Center, and watching a slide show world tour of museums provided for us by member Roxanne Williamson.



Our success and access to these events are possible only through the efforts and

cooperation of our members who are always on the lookout for interesting and different venues. A big thank you goes to Tom Watson who arranged our most recent tour to Laguna Gloria.

Our chair this year is Dianne Brewer, and she is doing an outstanding job. ## **Human Rights Day 2009 - December 10**

"Discrimination lies at the root of many of the world's most pressing human rights problems. No country is immune from this scourge. Eliminating discrimination is a duty of the highest order."

Human Rights Day 2009 on 10 December will focus on non-discrimination. "All human beings are born free and equal in dignity and rights". These first few famous words of the Universal Declaration of Human Rights established 60 years ago the basic premise of international human rights law. Yet today, the fight against discrimination remains a daily struggle for millions around the globe.

"Our main objective is to help promote discrimination-free societies and a world of equal treatment for all," says the High Commissioner who this year will mark Human Rights Day in South Africa.

She encourages people everywhere - including the UN family, governments, civil society, national human rights institutions, the media, educators, and individuals - to seize the opportunity of Human Rights Day 2009 to join hands to embrace diversity and end discrimination.

The realization of all human rights - social, economic and cultural rights as well as civil and political rights - is hampered by discrimination. All too often, when faced with prejudice and discrimination, political leaders, governments and ordinary citizens are silent or complacent.

Yet every one of us can make a difference. You are encouraged to celebrate Human Rights Day by advocating non-discrimination, organizing activities, raising awareness and reaching out to your local communities on 10 December and throughout 2010.
